Budget Appeals:

- We have \$10,000
 - This money can be allocated to groups for this semester or it can be kept for use in the future
- ACLU has submitted a late budget of \$400
 - \$100 Organizational Meeting
 - \$100 Title IX
 - \$100 Prior Restraint Panel
 - \$100 Know Your Rights
 - *Motion to reduce Know Your Rights to \$0; Motion to reduce Title IX to \$20*
 - *Motion to amend previous amendment to allocate \$50 to each event*
 - *Motion amended*
 - *New Motion fails*
 - *Motion to give ACLU budget as submitted*
 - *Motion passes; ACLU gets \$400*
- BLSA/OUTLAW: asking for an additional \$400 for joint happy hour

 - *Motion to add this language:* “In its meeting of January 13, the SBA voted to recommend ratification of this honor code.”
 - *Motion fails*
