Summer Institute for International Law & Policy

Now in its eighth year, Washington University School of Law and Case Western Reserve University School of Law are pleased to jointly offer an exciting opportunity to study international and comparative law during the summer at Utrecht University in The Netherlands—home of many of the world's most important international institutions.

Utrecht, founded by the Romans in 47 AD, has been a university town for centuries. One of the most enjoyable and beautiful of Dutch cities, Utrecht has a lively medieval charm, featuring majestic cathedrals, cobblestone-paved pedestrian streets, and winding canals, which date to the Middle Ages. The canal banks are lined with restaurants, bars, and night clubs, behind which rise magnificent homes built in the 16th and 17th centuries. With its pleasant summer climate and English as the prevalent second language, Utrecht is an ideal place for U.S. students to study abroad.

Most importantly, Utrecht is a short (30-min.) train ride from The Hague, headquarters of the International Court of Justice, the International Criminal Tribunal for the Former Yugoslavia, the Appeals Chamber of the International Criminal Tribunal for Rwanda, the Special Tribunal for Lebanon, the International Criminal Court, and the Permanent Court of Arbitration. It is also just a two-hour ride from Brussels, headquarters of NATO and the Council of the European Union. The Summer Institute features field trips to several of these institutions in The Hague and Brussels as well as many guest presentations by their leading officers.

Taught by prominent experts in the field from Europe and the U.S., including the former Chief Prosecutor of an International Criminal Tribunal, the Institute features six international and comparative law courses. The Summer Institute is accredited by the ABA, and is open to students in good standing

at ABA-accredited U.S. law schools and at non-U.S. undergraduate or graduate law programs, as well as graduates of those institutions. Nearly a third of our students each summer hail from outside the U.S. In addition to Dutch students, Summer Institute participants have come from Canada, China, France, Hungary, Indonesia, Israel, Italy, Macedonia, Moldova, Peru, Poland, Romania, Russia, South Africa, and Zimbabwe.

Students can enroll in two courses (one session) or three to four courses (both sessions), for a maximum of eight credits. Students should check with their registrar's office to determine transferability of credits. It is unlikely that participation in a summer program will accelerate graduation for a full-time student. Enrollment is limited to ensure small class sizes and intimate seminars with close interaction among students and faculty.

Facilities and Activities

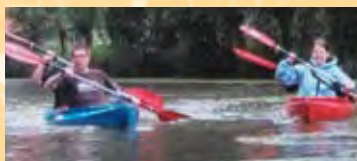
Founded in 1636, and home to more than 30,000 students, Utrecht is one of Europe's finest universities. The University's classroom facilities and library are located in historic buildings in the city center. All participants will be housed at the Apollo Hotel Utrecht City Centre, in the heart of Utrecht, just a few minutes walk from the train station, classroom buildings and library. Students are housed in shared double rooms, with color TV, bath and shower, and direct dial phone. The hotel provides a daily buffet breakfast and Internet access in each room at no extra charge.

During the Brussels fieldtrip, students get a briefing at NATO headquarters.

Courses are taught in the mornings and early afternoons, four days a week, with one day of each session used for a field trip to international institutions at The Hague or Brussels and the last Friday of each session for exams. The schedule provides time for class preparation, as well as socializing and travel to nearby cities, such as Amsterdam, Berlin, and Paris. In addition to visits to the international institutions in The Hague and Brussels, a variety of social events and sightseeing trips are offered as part of the program.



Scheduled activities include canal boat excursions, kayak trips, bicycle tours, and outings to the beach.

The Faculty

“Distinguished Visiting Jurist” David Crane is Distinguished Professor of Practice at Syracuse University College of Law. He was founding Chief Prosecutor for the Special Court for Sierra Leone from 2002 to 2005. During his tenure, he indicted Charles Taylor, then President of Liberia. Prior to his service with the Special Court, Prof. Crane served in various capacities in the U.S. federal government, including Director of the Office of Intelligence Review and Inspector General of the Department of Defense. He received his law degree from Syracuse and his Masters in African Studies from Ohio University.

Co-Director of the Summer Institute, Leila Nadya Sadat is the Henry H. Oberschelp Professor of Law at Washington University School of Law and Director of the Whitney R. Harris World Law Institute. During Spring 2011 she held the Alexis de Tocqueville Distinguished Fulbright Chair in Paris. An award-winning scholar with more than 75 articles and books to her name, Prof. Sadat is a well-known expert on the International Criminal Court, having attended both the Rome and Kampala conferences, meetings of the Preparatory Committee, and as a representative of Timor-Leste at the 8th Session of the Assembly of States Parties. From 2001–2003 she was a Commissioner on the U.S. Commission for International Religious Freedom. She is a Vice-President of the International Law Association (American Branch) and the International Association

of Penal Law (AIDP) and a member of the American Law Institute. Prof. Sadat received her B.A. from Douglass College, her J.D. from Tulane (*summa cum laude*), and graduate degrees from Columbia University (LL.M., *summa cum laude*) and the Sorbonne (diplôme d'études approfondies).

Juscelino F. Colares is Professor of Law at Case Western Reserve University School of Law, where he teaches international trade, international environmental law, and international business-related courses. He was previously a professor at Syracuse University College of Law. He received his LL.B. from the University of Brasilia/Federal University of Ceara in Brazil, his M.A. and Ph.D. from University of Tennessee, and his J.D. from Cornell Law School. He has worked as an Associate for Dewey & LeBouf LLP, and was judicial clerk for the Hon. Jean-Louis Debré, President of the French Constitutional Council.

Héctor Olásolo is Professor of International Criminal Law and Procedure at the University of Utrecht, and Director of the Utrecht School of Law's Clinical Programme on Conflict, Human Rights and International Justice. He is the President of the Ibero-American Institute of The Hague for Peace, Human Rights and International Justice (IIH). He previously served as a Legal Officer in Chambers at the International Criminal Court (2004–09) and as a member of the Legal Advisory and Appeal Sections of the International Criminal Tribunal for the Former Yugoslavia Office of the Prosecutor (2002–04). He was also a member of the Spanish Delegation to the Preparatory Commission for the International Criminal Court (1999–2002). Prof. Olásolo graduated from the University of Salamanca with a law degree in 1996 and a Ph.D. in 2003. He received his LL.M. from Columbia University (New York) in 2001 and was pronounced as a Kent Scholar in 2002.



In addition to the major field trips, we arrange for smaller groups of students to attend trial sessions and meet with the officers of the Yugoslavia Tribunal.

Dorsey Ellis, Jr. is the William R. Orthwein Distinguished Professor of Law Emeritus and was Dean of the Washington University School of Law from 1987 to 1998. He practiced law with Cravath, Swaine & Moore in New York before joining the faculty of the University of Iowa, where he taught for nineteen years. He has taught U.S. Antitrust Law since 1968 and in 2006 restructured that course to one in comparative competition law – Antitrust in the World Economy. He previously taught at the Summer Institute as well as in Belgium, Oxford, Tokyo, and as a Fulbright Fellow in Lisbon. He was a consultant to the Federal Trade Commission and is a member of the American Law Institute, American Bar Association Antitrust Law Section, and Academic Resource Corps of the Association of American Law Schools.

Ruqaiyah A. Yearby is Professor of Law and Associate Director of the Law-Medicine Center at Case Western Reserve University School of Law. Prof. Yearby earned her B.S. in Honors Biology from the University of Michigan, her M.P.H. from Johns Hopkins School of Public Health, and her J.D. from Georgetown University Law Center. Before becoming a professor, she was an Assistant Regional Counsel at the U.S. Department of Health and Human Services and served as judicial clerk for the Honorable Ann Claire Williams of the U.S. Court of Appeals for the Seventh Circuit. Prior to joining Case Western, Prof. Yearby was an Associate Professor at the University at Buffalo Law School and the School of Public Health and Health Professionals, where she served as Director of the J.D./M.P.H. program, Director of the J.D./Pharm.D. program, and Co-Director of the Health Law Concentration.

Tom Zwart, Co-Director of the Summer Institute, is Professor of Law at Utrecht University, and Director of the Netherlands School of Human Rights Research, a joint initiative of the faculties of law of several Dutch universities. He was formerly Dean of Graduate Studies, and LL.M. Director of the Utrecht University Law School. A leading authority in the field of comparative law and the internationalization of public law, he has been a visiting scholar at a number of law schools around the world. Prof. Zwart served as Head of the European and Legal Affairs Department of the Dutch Home Office from 1993 to 1997. As such, he acted as counsel to the Dutch Deputy Prime Minister, the Council of Ministers of the European Communities in Brussels, and the Council of Europe in Strasbourg.

Dates, Tuition, and Fees

Students attending the first session should arrive in Utrecht and check in at the Apollo Hotel Utrecht City Centre on Sat., June 2. There will be an orientation session and welcoming reception at 1:30 pm on Sun., June 3, followed by a canal boat cruise. Session 1 classes run Mon., June 4–Fri., June 22. Session 2 classes run Mon., June 25–Fri., July 13. Hotel check-out and departure will be on Sat., July 14.

There are three separate fees for the Summer Institute:

(1) A non-refundable \$100 application fee that must accompany your application. (2) A \$500 non-refundable deposit due within two weeks of notification of acceptance. (3) An additional \$2,000 (for one session) or \$3,500 (for both sessions) for tuition, reading materials, and activities.

In addition, subject to exception only with advance approval in extraordinary circumstances, students from outside The Netherlands must stay at the Apollo Hotel Utrecht City Centre, where we have negotiated a special rate. First session hotel rates for a shared double room are 80.85 Euros per night (for a total of 1697.85 Euros or approximately \$2300); second session rates are 59.85 Euros per night (for a total of 1256.85 Euros or approximately \$1700). The total for both sessions is 2954.70 Euros (approximately \$4000). Prices include tax, breakfasts, and in-room Internet access. You must pay the hotel at check in. Single rooms are available during each period for double the shared-room rate.

A small number of full-time Utrecht University students are eligible for a **full scholarship**. Interested students should contact Tom Zwart, Utrecht Director of the Program; scholarship recipients will not be provided lodging. A **half scholarship** is available for students from universities outside the U.S. and Canada. Contact Michael Peil for details.

Participants are responsible for making their own travel arrangements prior to departure for Utrecht. Passports are required for travel to The Netherlands and are the responsibility of each student. Visas are not required for U.S. citizens traveling to The Netherlands. Participants should contact the financial aid officer at their own law schools to determine financial aid eligibility.

Late Participant Withdrawal

Tuition: If a student withdraws prior to June 22, 2012, (s)he will receive a full tuition refund within twenty (20) days. If a student withdraws after that date, (s)he will receive a refund of either (a) full tuition, in the case of a student enrolled only in the second session, or (b) half-tuition, in the case of a student enrolled in both sessions. Hotel Fees: Although the Summer Institute negotiates a reduced lodging rate with the Apollo Hotel, participants are in a

direct contractual relationship with the hotel. Therefore, lodging at the Apollo Hotel is subject to the terms and conditions of the Hotel, including any early departure fees. We will provide the Apollo Hotel's cancellation policy upon request.

Cancellation Policy

Washington University School of Law and Case Western Reserve University School of Law reserve the right to alter or cancel this program. Cancellation can occur in the event of program underenrollment by April 30, 2012, or unforeseen international events that could substantially inhibit program operations or seriously compromise student safety. If we cancel the program, all tuition and fees will be returned.

To Apply

The application deadline is March 30, 2012, but because enrollment is limited, we recommend that you apply early to ensure admission. The application fee is \$100. Admission is open on a first-come, first-selected basis to any law student at an ABA accredited law school, as well as any student enrolled in a non-U.S. undergraduate or graduate law program, who is in good academic standing as determined by their home school and who at the time of the Summer Institute will have completed the first year of full-time study or its equivalent in part-time study.

Please use the application form at the end of this brochure. Notification of acceptance will begin in February 2012. Within two weeks of notification of acceptance, you are required to provide a \$500 non-refundable tuition deposit. The balance of your tuition (\$2000 for one session or \$3500 for both sessions) must be paid before June 1, 2011. You will be required to pay the full cost of your lodging by credit card or cash (no traveler's checks) when you check in at the Apollo Hotel on June 2.

Session 1 | June 4– June 22

9:00 am–10:50 am

World Trade Organization Law & Dispute Settlement

Taught by Professor Colares

This course is about “WTO law,” defined as an amalgam of increasingly intersecting transnational and domestic norms and practices affecting cross-border trade among nations. Students will read and analyze: (i) certain provisions of the different WTO Agreements; (ii) panel and Appellate Body decisions; and (iii) commentary from secondary sources (e.g., empirical and qualitative articles on trade law and policy, etc.), to determine the extent to which WTO adjudicators have interpreted and applied these legal texts in accordance with the announced goals and intent of the trade law-making bodies (original drafters of WTO Agreements, Ministerial Conference, etc.).

11:00 am–12:50 pm

International Criminal Law and Procedure

Co-Taught by Professors Sadat and Olásolo

This course begins by focusing on issues related to core international crimes, in particular: genocide (in the context of the ICC’s Bashir Arrest Warrants); crimes against humanity (with respect to guerrilla movements, paramilitary groups and terrorists); the relationship between terrorism and armed conflict; and the crime of aggression (in light of the ICC Review Conference). The course then examines states’ obligations to investigate and prosecute international crimes and challenges presented during periods of transitional justice. Next, it analyzes the interplay between national jurisdictions and international criminal tribunals, focusing on the primacy and complementarity regimes and on universal jurisdiction. Finally, it surveys international criminal procedure, including investigation of situations and case selection, confirmation of cases, and trial and appeals proceedings, with special attention to the role of victims. Participants will visit the international criminal courts and tribunals in The Hague and participate in a moot court exercise.

2:00 pm–3:50 pm

Contemporary Developments in International Human Rights Law

Taught by Professor Zwart

This course focuses on human rights, their status as international law, and the salient issues in the implementation and enforcement of that law. After considering the philosophical origins of human rights, the course will examine the interpretation of the major human rights instruments and their implementation by international, regional, and domestic bodies, with particular attention to contemporary developments and challenges.

Session 2 | June 25–July 13

9:00 am–10:50 am

Atrocity Law and Policy

Taught by Distinguished Visiting Jurist David Crane, former Chief Prosecutor of the Special Court for Sierra Leone

Taught from a unique insider’s perspective, and featuring guest lectures by Tribunal prosecutors and judges, this course examines the establishment of the international and hybrid criminal tribunals and significant jurisprudence that is emerging from them. Discussion will center on the composition of the courts, the nature of the crimes, the legal principles at issue, and the practical difficulties confronting international criminal justice, with particular attention paid to the negotiating histories of the International Criminal Court, the International Criminal Tribunals for the former Yugoslavia and Rwanda, the Special Court for Sierra Leone, and the Extraordinary Chambers in the Courts of Cambodia.

11:00 am–12:50 pm

International and Comparative Antitrust Law

Taught by Professor Ellis

Antitrust or competition law is intended to make the market system function fairly and efficiently. This course focuses on the application of that law to monopoly and competition, the role that competition plays in society, and the ways in which U.S. and E.U. courts and agencies have applied their law to further competitive and other goals. Substantive law considered in the course includes prohibition or regulation of monopolization, abuse of dominance, horizontal restraints among competitors, vertical restraints between manufacturers and dealers, and mergers, and the interplay between antitrust law and the law protecting intellectual property. The course will compare and contrast the U.S. and E.U. approaches to those issues and the extraterritorial reach of their legal regimes. Prior study of economics is not required.

2:00 pm–3:50 pm

Emerging Biotechnology: Ethical Issues for a Global Society

Taught by Professor Yearby

Emerging biotechnologies have generated complex bioethical, public health, and human rights challenges that impact our global society. Thus, the study of Bioethics, Public Health, and Human Rights is vital. After an overview of biomedical principles, public health law, and human rights documents, the course will examine such issues as biobanking, synthetic biology, DNA forensics, patenting of genes, outsourcing medical research, reproductive rights, and bioterrorism, as well as other timely and pertinent issues.
